

INTENDED USE

OPERATION INSTRUCTIONS

Refer to picture at left to see Inflatable Hair Shampooer in use.

- 1. Pull clamp off nozzle (if necessary for inflation) and inflate Hair Shampooer until ring is firm.
- 2. Close clamp on nozzle so that air does not escape.
- 3. Position the patient so that their head is close to the side of the bed where you will be working.
- 4. Slide pillow down so that it is under the patient's shoulders and neck, not under patient's head.
- 5. Place Hair Shampooer under patient's head.
- 6. Ensure drainage hose is hanging into collection bucket on floor, and that hose is clear and open to allow free flow of water into the bucket.
- 7. Using a pitcher to wet hair, proceed with shampoo. The water in the Hair Shampooer will pool and drain off through the hose into the bucket.
- 8. Rinse well to prevent soap build-up.
- 9. Wipe Hair Shampooer as dry as possible with a clean, dry cloth, then leave it inflated for several hours to allow complete drying before storage.
- 10. When dry, deflate the Hair Shampooer by pulling the clamp off the nozzle. When the Hair Shampooer is completely deflated, fold and store it away from direct sunlight and heat.
